LICENSING OF BUILDERS

- Students need to have at least 5 years (in aggregate) of practical experience in the execution of construction projects (whether in Singapore or elsewhere) after attaining the above mentioned program in order to apply to BCA as a General Builder GB Class 1 Technical Controller

ENTRY REQUIREMENTS

- An honours degree at second class or above/ equivalent in facilities management, building surveying, construction or any other construction related subject; Or
- Other equivalent qualification from recognised institutions (e.g. Bachelor of Building and Project management programme awarded by SUSS) and relevant industries experience (e.g. Construction Management, Facilities Manager, Building Surveyor, Real Estate Manager, Engineering, etc.); Or
- Mature students: At least 30 years old with at least 8 years of relevant working experiences (e.g. Building Maintenance Manager, Construction Manager, Building Surveyor, Real Estate Manager, Engineering, etc.) and had obtained other degree qualification will be considered on a case to case basis.
- Applicants whose first language is not English or whose previous qualification was not taught and assessed in English must provide evidence of attainment in the English Language by achieving an IELTS 6.0 or an equivalent qualification.
- All applications are subjected to the approval of Birmingham City University.
