

## MODULE EXEMPTION REQUEST FORM

### IMPORTANT NOTE:

1. This form is to be completed by applicants requesting for exemption.
2. Exemption (s) may be granted for certain modules to applicants who have taken comparable modules in other programmes.
3. All application for exemption (s) must be submitted with certified true copies of the certificates and transcripts. The syllabuses of the module (s) must be attached.
4. The module(s) you previously successfully completed must be similar in nature to the module from which you now seek exemption. Learning from a number of successfully completed modules may be combined in order to gain a single module exemption
5. The module(s)/subject(s) previously completed must be either at the same (or higher) level in the National Framework of Qualifications than the module for which you currently seek the exemption, (e.g., if you seek an exemption from a level 3 module, you must have previously successfully completed a similar level 3 or level 4 module).
6. The maximum number of exempted modules that could be exempted from the programme shall not be more than 40% of the programme.
7. The student must continue to attend class as normal until he/she receives written confirmation granting an exemption for the module.
8. No refund of module fee will be made for exempted modules.
9. All information provided is treated with strictest confidentiality and are meant for internal use only.
