ACADEMIC REQUIREMENT

- Obtained at least 2 GCE A-Level passes, including Mathematics and *English; OR
- Obtained International Baccalaureate Diploma (at least 24 points) or other equivalent pre-university certifications; OR
- Completion of GSTM Diploma (Specialized in Business Management) or equivalent, OR
- Completion of GSTM Diploma (Specialized in Hospitality and Tourism Management) and passed GSTM bridging Economics and Law modules, OR
- Completion of GSTM (Specialized in Event Management) or GSTM Diploma (Specialized in Events, Hospitality and Tourism Management) and passed GSTM bridging Accounting, Economics and Law modules, OR
- Completion of GSTM Diploma (Specialized in Logistics and Supply Chain Management) and passed GSTM bridging Accounting and Law modules, OR
- NUS High School Diploma; OR
- Polytechnic Diploma (e.g. Diploma in Accounting/ Business/ Management/ IT/ Computing/ Hospitality/ Psychology); OR
- Other PEI qualifications (e.g. Diploma in Accounting/ Business/ Management/ IT/ Computing/ Hospitality/ Psychology that is equivalent to GSTM's Diploma) will be assessed on a case-by-case basis; OR
- Matured student: At least 30 years old with at least 8 years of relevant working experience will be considered.

ENGLISH LANGUAGE REQUIREMENT

- *A pass in English at GCE 'O' Level, or IELTS 5.5 and or equivalent; Or
- Completed a prior Diploma or equivalent where the medium of instruction is English
