

GSTM PRIVACY STATEMENT

(Last updated: 31 October 2023)

This statement outlines our information practices and the handling of your personal data by GSTM when you engage with our websites and apps, including mobile sites and applications (collectively, the "Site").

GSTM collects personal data to support various university functions, including teaching, learning, research, and administration.

If you're only browsing the Site or using the search function, we do not collect data that can identify you individually. The Site automatically logs information, such as your IP address, cookie data, and requested pages. User sessions are tracked, but anonymity is maintained. You can choose to disable cookies in your web browser settings, but this may limit the Site's functionality.

If you submit a request via our online form or send us an email with personal data for processing, we may share relevant information within GSTM or with government ministries/agencies, or other universities if required to serve you efficiently, unless prohibited by law. We may disclose personal data when required by law or a court order. GSTM does not share your personal data with private entities except authorised entities acting on our behalf.

For your convenience, when you conduct a transaction on this Site, we may display data you previously provided to us, government ministries/agencies, or authorised entities. This is to save you time and effort. If the displayed data is outdated, please provide updated information. GSTM retains your personal data only as necessary for legal or business purposes.

GSTM has implemented security technologies, policies, and procedures to protect the electronic storage and transmission of personal data. While we strive to secure our networks,



internet transmission is not entirely secure, and GSTM cannot guarantee the security of your data online. We recommend taking safety precautions, as any transmission is at your own risk.

This Site may contain links to independently managed websites within the GSTM network and external sites with different data protection and privacy practices. GSTM is not responsible for their content and privacy practices, so we encourage you to review their privacy notices. GSTM does not explicitly or implicitly endorse linked sites or their content and will not be liable for any damages or losses related to their use.

Please be aware that when you voluntarily share personal data online, it may be collected and used by others. By posting personal data online in publicly accessible areas, you may receive unsolicited messages from other parties.

Google Analytics
